

LANDFILL HOURS - 2011

Effective 1/1/11 additional \$.90/ton surcharge applied to all trash/landfill items collected under C.R. S. 25-16-104.5 and 6 CCR 1007-2 1.7

Beginning 4/1/11, the surcharge will increase to \$1.30/ton

*All hand unloaders need to be in 30 min. prior to closure. ALL customers must be unloaded & out the gate by 4:00 pm or double charges will apply.

Holiday closures – New Years Day, Memorial Day, July 4th, Labor Day, Thanksgiving, Christmas, & Christmas Eve is sometimes a ½ day.

SCALE PROCEDURE

All vehicles should stop before the scale approach, and then proceed slowly. Please pull off scale slowly until you are clear.

Allow the vehicle in front of you to pull completely off the scale before pulling on. If you have a red light, wait until you get the green light. In order to get accurate weights, the scale needs to zero out between vehicles.

Do not shift gears on the scale or come to an abrupt halt. Sudden jerks to the scale can either throw off the calibration or actually damage the scale mechanism.

ALL LOADS MUST BE COVERED – DOUBLE CHARGE FOR UNCOVERED LOADS

Accepted payment – cash or check with proper id – no credit cards accepted

Speed limit throughout landfill 10 mph. Landfill equipment has right of way. One-way traffic.

NO cell phone use, scavenging, children or pets out of vehicle, or smoking within 100 ft of trash area. No

paints, tires, batteries, liquids, fuels, oils, or propane tanks in your trash load. Special requirements and/or fees apply to these items.

*Structural & topsoil cannot contain trash and is free of mud and/or excess moisture. Any material not meeting the requirements will be charged the loose trash rate.

*Scrap metal – no contaminants – barbed wire, chicken wire, or rolled fencing, rebar, cable, propane or fuel tanks, brake shoes. Barrels only accepted with lids off or cut open.

*Slash & Wood Construction must be separate loads for lower rates – raw dimensional lumber only - no creosoted, painted, stained or treated lumber in constr. wood – no plywood or OSB. No trash or other construction debris. No metal hardware.

Contaminated loads charged at loose trash rate, along with applicable surcharges and additional hauling fees.

Effective 1/1/09 STUMPS must be separated from slash. They will be considered trash & go into landfill.

***Chip product – There is a 2 inch maximum size requirement to qualify for the chip price.** The price defaults automatically to the slash rate if product does not meet these criteria. Also, no contamination in the load – no trash, limbs, log ends, rocks or dirt. Trash or slash rates apply to contaminated loads.

*Special handling rates may apply for any special equipment or handling needs - \$60.00 per 15 minutes.
