- ✔ Recycle newspaper, magazines, office paper, cardboard and co-mingled containers (plastic, glass aluminum).
- ✔ Educate your staff and customers about your sustainability efforts and commitment.
- ✔ Display Frisco Clean Tracks Business decal.
- ✔ Attend Frisco Clean Tracks Business Workshop (1 hour).
- ✔ **Identify and accomplish (by the end of the year) at least one new sustainable action that your business will achieve this year.**

	- Replace older (T12-type, magnetic ballast) fluorescents with more efficient fluorescents (T8 or T5, electronic ballast).

	Heating, Cooling and Ventilation (36% of energy use)
2	<input type="checkbox"/> Install programmable thermostats to maximize heating and cooling efficiency.
1	<input type="checkbox"/> Turn down water heater thermostats to 120 degrees F.
5	<input type="checkbox"/> Install/maintain appropriate insulation (in attic, walls).
5	<input type="checkbox"/> Install/maintain appropriate air sealing (caulk/sealing/weather stripping around windows and doors; sealing around connections to unconditioned space, especially the attic).
	Water (9% of energy use)
1	<input type="checkbox"/> Install low-flow fixtures on faucets/shower heads.
2	<input type="checkbox"/> Replace old toilets with new low-flush toilets, or improve efficiency of existing toilets.
5	<input type="checkbox"/> Replace water intensive landscaping with native or water-saving landscaping.
1	<input type="checkbox"/> Install an auto shut-off device for sprinkler system.
	Appliances (16% of energy use)
5	<input type="checkbox"/> Purchase Energy Star computers, monitors, printers, and other commercial appliances.
1	<input type="checkbox"/> Minimize phantom load with smart strips.

Renewable Energy	
15	<input type="checkbox"/> Install renewable energy system, or purchase share in local solar garden.

Waste Reduction	
5	<input type="checkbox"/> Have an incentive program in place to encourage the use of re-usable bags.
5	<input type="checkbox"/> Purchase unbleached, post-consumer recycled paper and other paper products.
5	<input type="checkbox"/> Use non-toxic and environmentally friendly cleaning supplies.
5	<input type="checkbox"/> Purchase reusable, recyclable or compostable products such as dishes, utensils and hand towels.
5	<input type="checkbox"/> Recycle hard-to-recycle items: phone books, printer/toner cartridges, cell phones, hazardous waste, building materials and batteries.
